All that piece, parcel or tract of land situate, lying and being in 2nd St. Johns Parish, Berkeley County, State of South Carolina, south of Road S-8-34 and northwest and west of the Moncks Corner Municipal Airport, containing 73.81 acres, and being fully shown and delineated as Tract A, containing 59.11 acres, and Tract B, containing 14.7 acres, on a plat by Cleatwood E. Droze, RLS, dated September 16, 1986, and recorded in the office of the RMC for Berkeley County in Plat Book ~~40~~ ⁶⁸ B at Page 68.
