- A. Mortgage - This document, which is dated February 23, 1999, will be called the "Mortgage". **0074124 Bk: 1769 Pg: 0266**
- B. Mortgagor - Richard C. Bins and Mary Ellen Bins will sometimes be called "Mortgagor" and sometimes simply "I", "Me", "my", "mine", "myself", and "us" refer to the Mortgagor.
Mortgagor's residence address is 1012 Cass Drive, Moncks Corner, SC 29461
- C. Lender - Wachovia Bank, N.A. will be called "Lender" and sometimes simply "you". "Your" and "yours" refer to Lender. Lender is a national banking association which was formed and which exists under the laws of the United States of America.
Lender's address is PO Box 700, Charleston, SC 29402
- D. Note - The note, note agreement, or loan agreement signed by Richard C. Bins and Mary Ellen Bins and dated February 23, 1999, will be called the "Note". The Note shows that I have promised to pay Lender Dollars (\$ 25,755.00) plus finance charges or interest at the rate agreed to in the Note which I have promised to pay in full by February 23, 2000

- E. Property - The Property that is described below in the section entitled "Description Of The Property" will be called the "Property".

II. My Transfer To You Of Rights In The Property

On this date, because you loaned me the money for which I gave you the Note, I mortgage, grant and convey the Property to you, your successors and assigns, subject to the terms of this Mortgage. This means that by signing this Mortgage, I am giving you those rights that are stated in this Mortgage and also those rights that the law gives to lenders who hold mortgages on real property. I am giving you these rights to protect you from possible losses that might result if I fail to:

- A. Pay all the amounts that I owe you as stated in the Note and any future advances made under Paragraph 17 of this Mortgage.
- B. Pay, with interest or finance charges, any amounts that you spend under this Mortgage to protect the value of the Property and your rights in the Property.
- C. Keep all of my other promises and agreements under the Note and/or this Mortgage.

This Mortgage secures any renewals, extensions, refinancings, and/or modifications of the Note, and any substitutions for the Note.

III. Description Of The Property
