 COUNTY OF BERKELEY) **AMENDMENT TO SUPPLEMENTARY
 DECLARATION OF COVENANTS,
 EASEMENTS AND RESTRICTIONS
 FOR BRAEMOOR SUBDIVISION**

WHEREAS, heretofore on August 7, 1989, Centex Real Estate Corporation did cause that certain Supplementary Declaration of Covenants, Conditions, Easements and Restrictions for Braemoor Subdivision ("Declaration") to be filed in the RMC Office for Berkeley County in Book C263, Page 270; and *5-269*

WHEREAS, Section Thirty-Three of said Declaration provides for amendment of said Declaration by a majority of the Owners together with approval by a majority of the Board of Directors of the Association; and

WHEREAS, Centex Real Estate Corporation is the owner of the majority of the lots in Braemoor Subdivision and the amendment as set out below has been approved by a majority of The Board of Directors of Braemoor Homeowners Association, Inc.;

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS, that Centex Real Estate Corporation does hereby ammend the Supplementary Declaration of Covenants, Easements and Restrictions for Braemoor Subdivision dated August 1, 1989, and recorded in the RMC Office for Berkeley County in Book C263, Page 270 in the following particulars:

1. Section Eight, subsection c is hereby amended to read as follows:

"Fences may be erected on the Lots, extending from the rear corners of a dwelling around the rear of a Lot and shall not exceed six (6') feet in height; provided, however, that the portion of a fence facing a street shall be of an ornamental nature, consisting of wood, brick or such other material as may be approved by the Architectural Review Board. All fences, including the ornamental nature thereof, must be approved in writing by the Architectural Review Board and Goose
